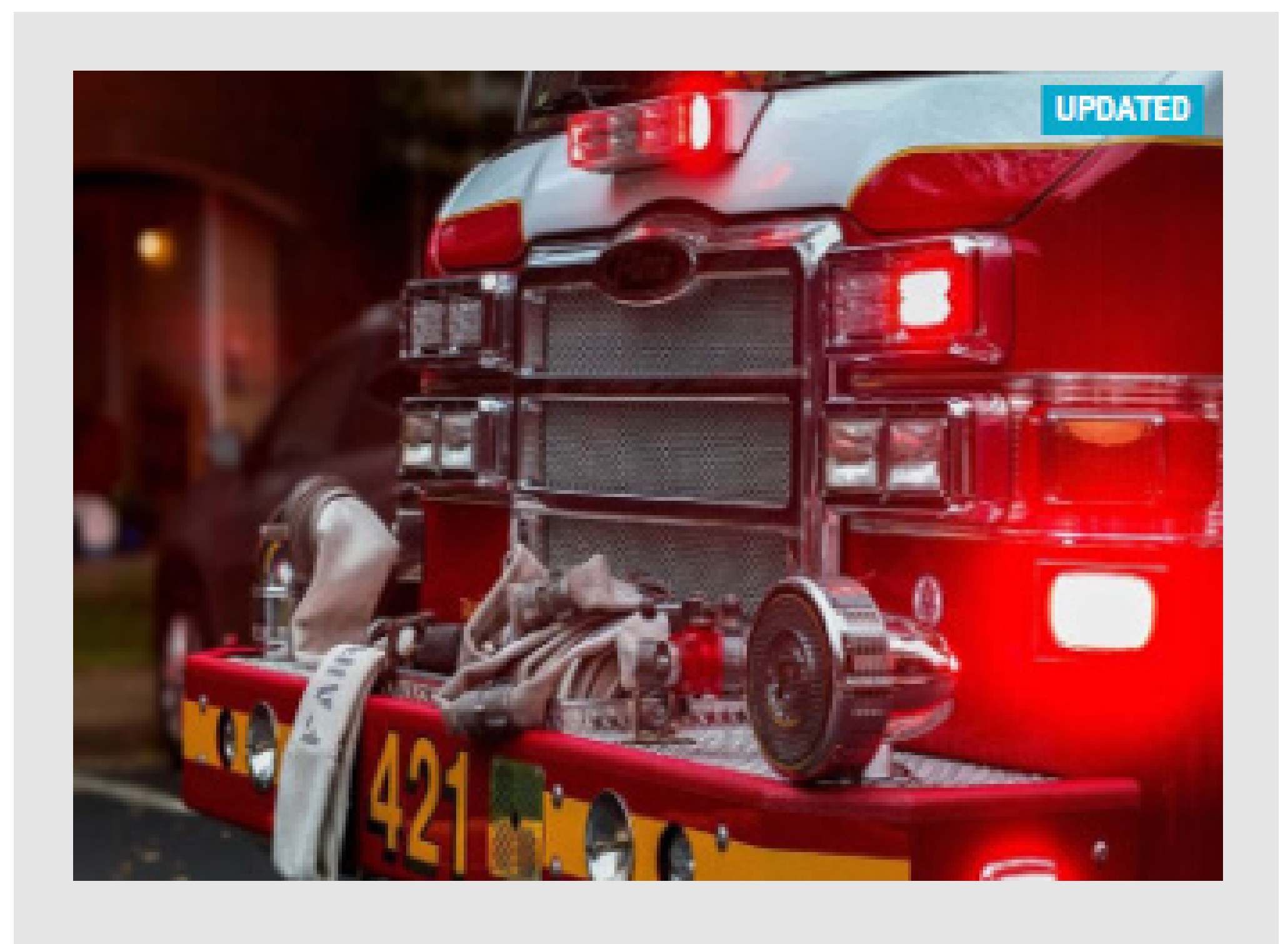
The Benefits

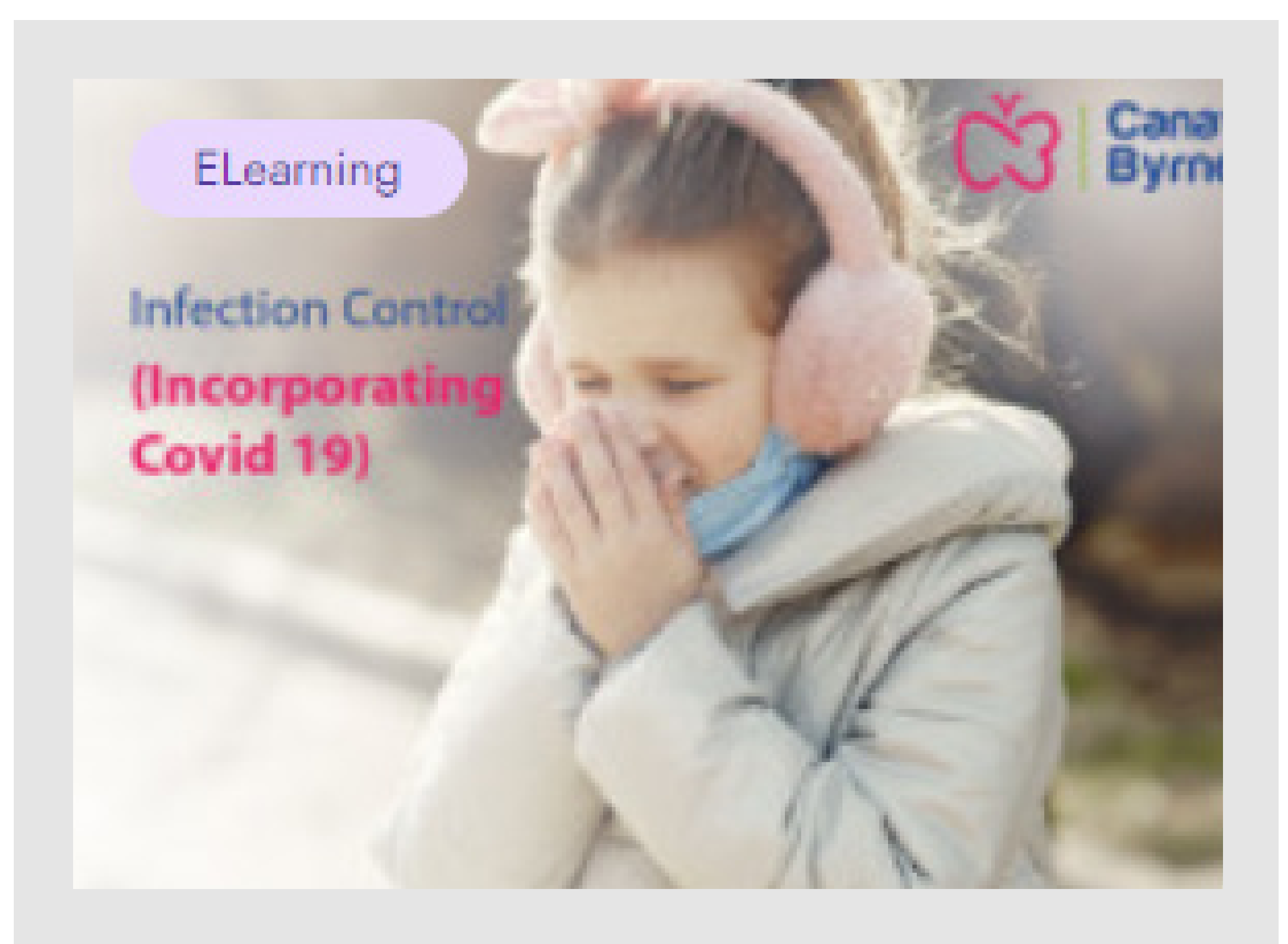


Manual Handling

Infection Control (Including Covid 19)

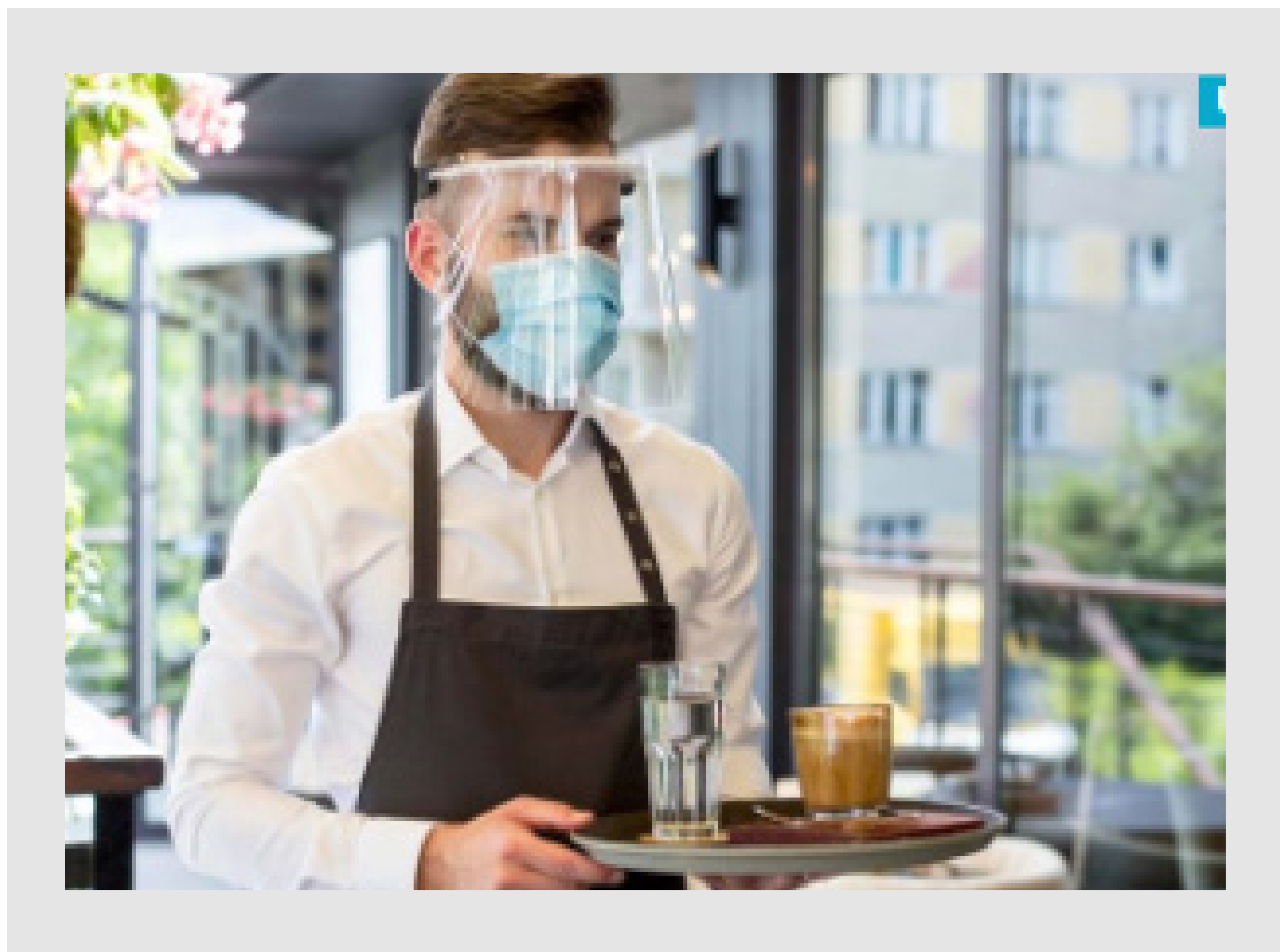
This e-Learning course provides essential tips to assist management implement a robust Infection Control Policy for the Early Years & School Aged Care sector.

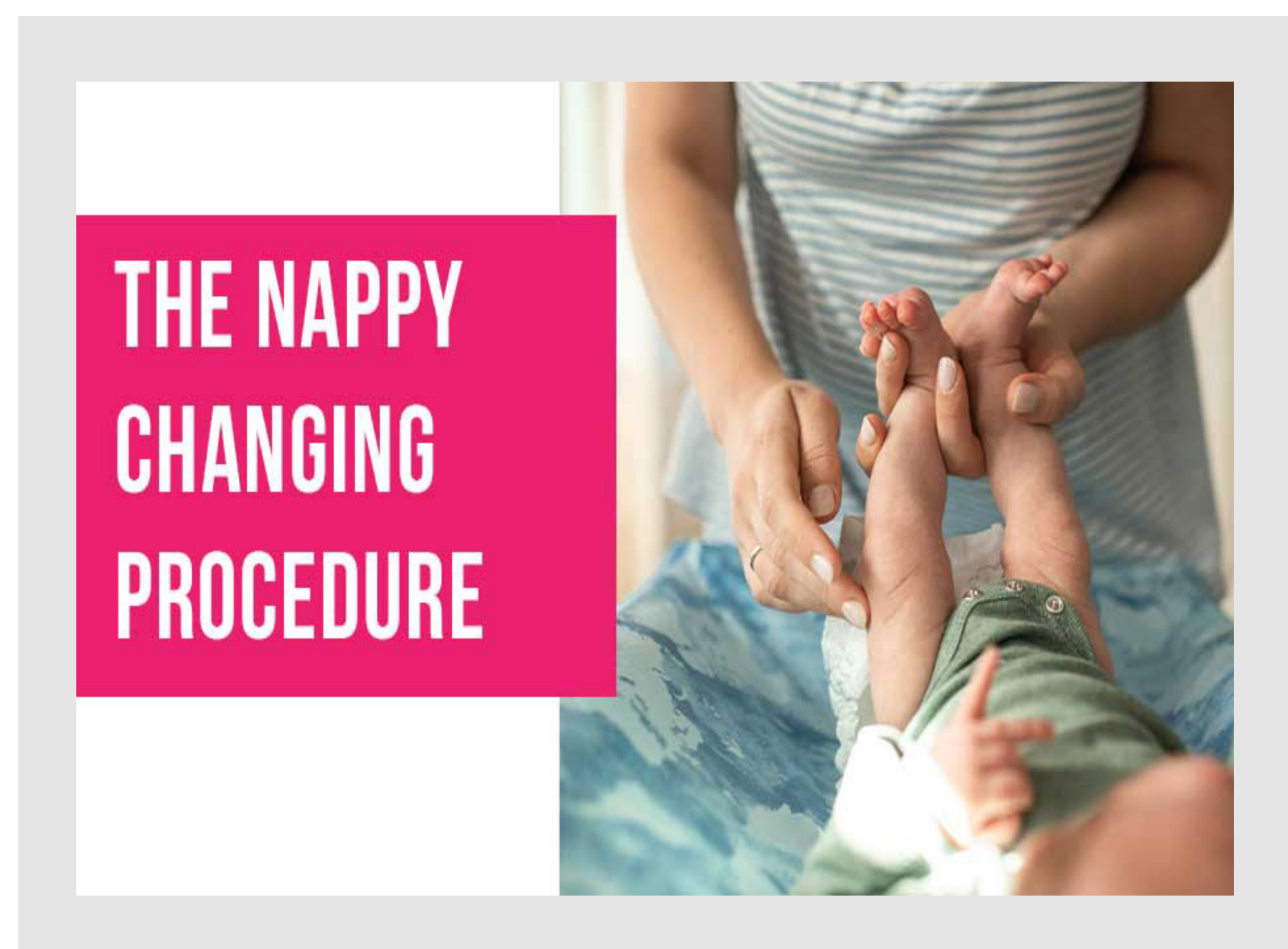

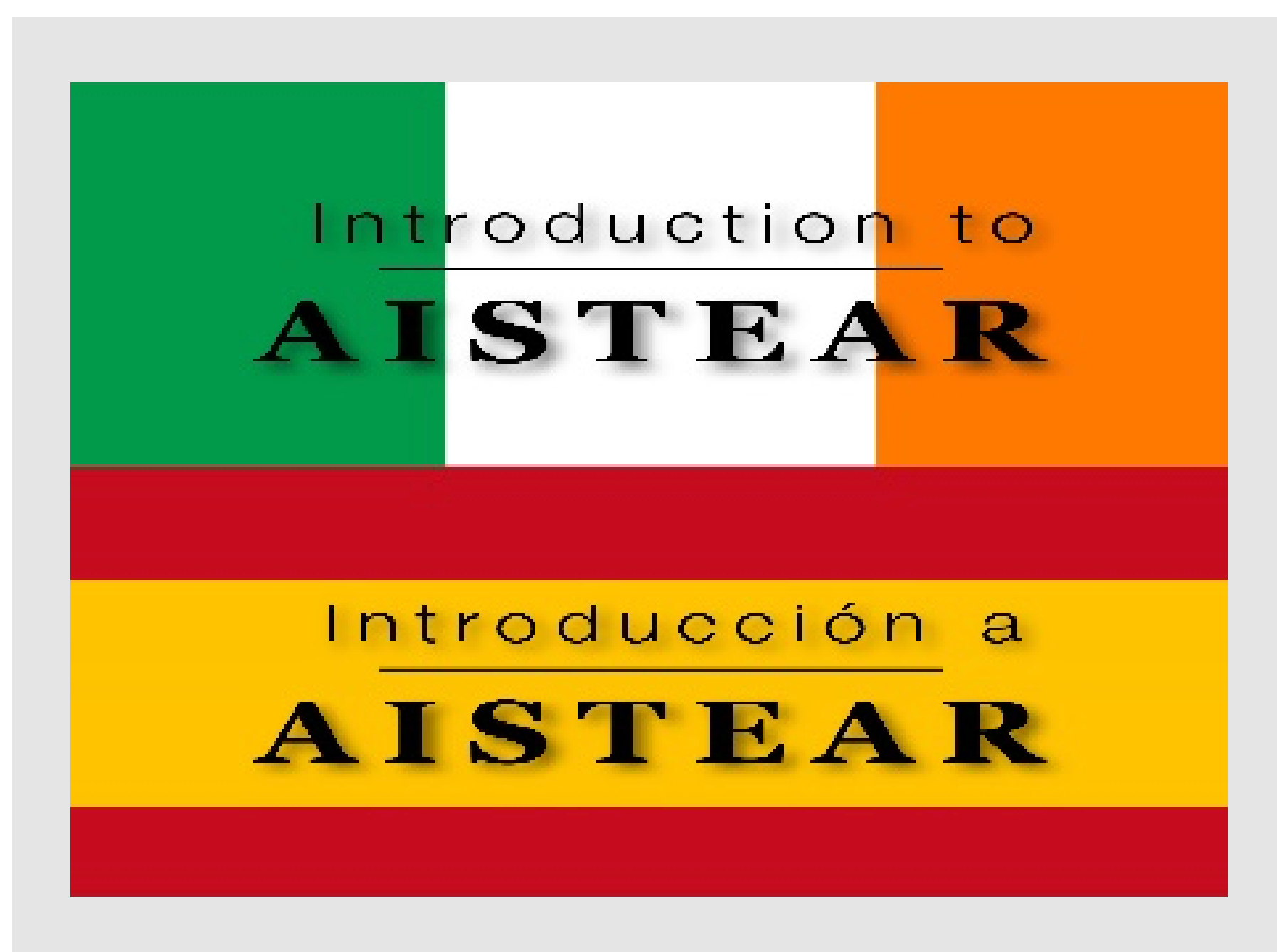

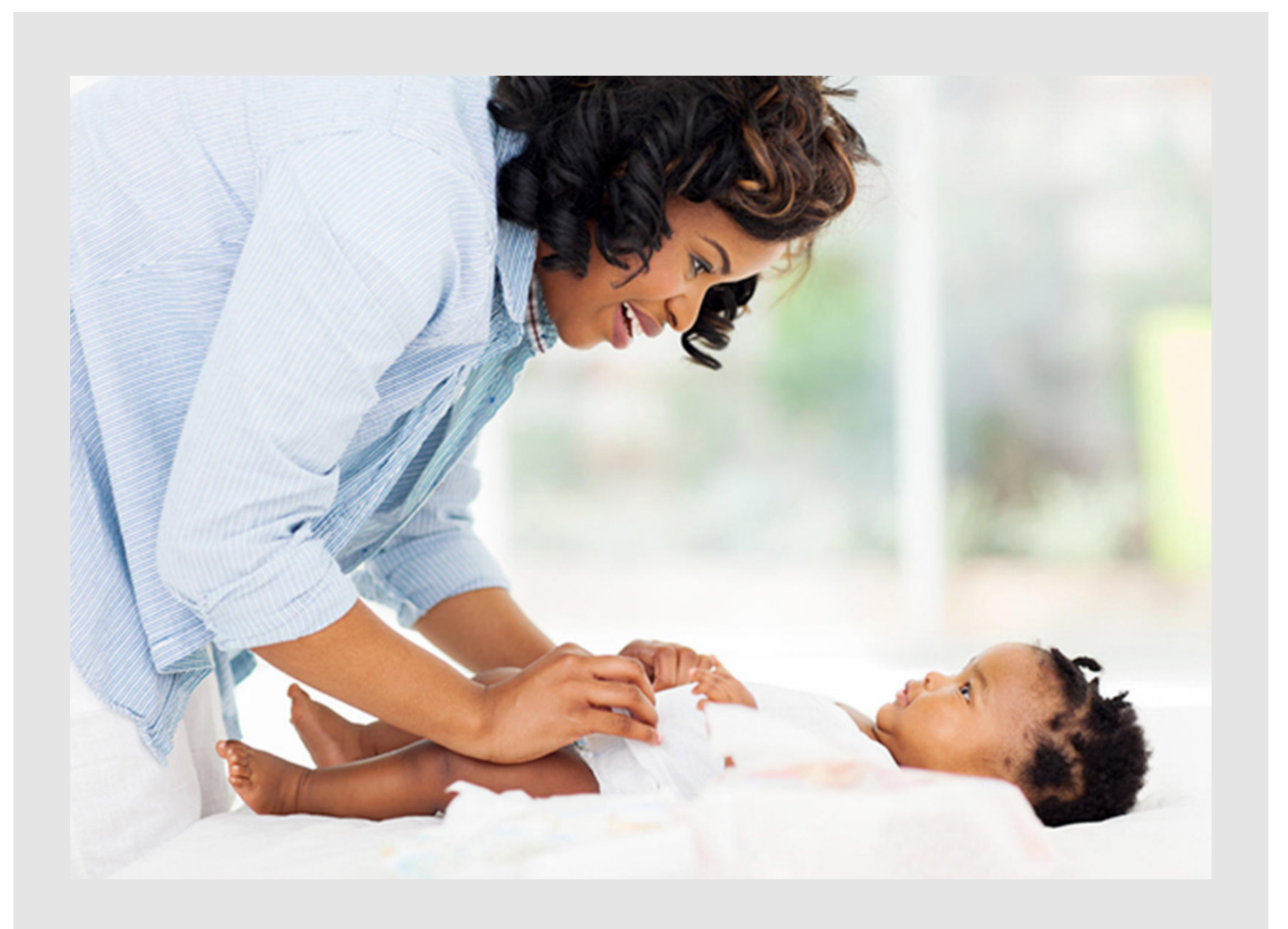


Introducción a Aistear
